## Poorer Health

---

### HR 3200 Plan Will:

**Discard the elderly and the unborn:** Mandates counseling of elderly on "end of life" options, code words for "go to hospice, no care for you." (p. 425 5-next p.) Specifies what life sustaining care the elderly will receive (p. 427 Lines 15-24), (p. 429 Lines 10-25), (p. 430 Lines 11-15) US Taxpayers will be forced to fund abortions. (p. 770 Sec. 1714)

**Discourage entry into health professions:** Government sets prices for all services and effectively sets capricious compensation rates for physicians. (p. 127 Lines 1-16), (p.126 Lines 10-15), (p. 241 Lines 6-8), (p. 253 Lines 10-18)

**Make education of physicians a government enterprise:** Government determines location where a physician conducts residency. (p. 660-671) Regulates all teaching hospitals. (p. 676 Sec 1503)

**Transfer medical decisions away from doctors and patients to faceless bureaucrats:** A government committee will decide what treatment you get. (p. 30 Sec. 123) And a commissioner will enforce. (p. 42 Lines 6-11), (p. 438 Sec. 1236)

**Rations care and punishes readmissions to hospital:** Annual limitations are established. (p. 29 Lines 4-16) Centrally planned healthcare capacity limits. (p. 238 Sec 1121) Physicians penalized for readmissions. (p. 298 Lines 9-11)

## Higher Cost

---

### HR 3200 Plan Will:

**Not decrease overall cost:** The Congressional Budget Office has determined that the plan may increase overall cost of healthcare - productive people will pay the bill through many direct and hidden taxes.

**Cause the loss of jobs and closure of businesses:** Through regulation and taxation, businesses of all sizes will be compelled to provide health coverage. (p. 110, Lines 7-18), (p. 144, Sec. 312) The plan greatly increases progressive taxation, which always results in decreased economic growth. (p. 198 Lines 1-6)

**Hide the costs of the public plan:** Allows unlimited transfers between government trust fund accounts such as Social Security. (p. 110 Lines 19-24) Gov will not have to so costs that were required to garner "savings." (p. 201 Lines 12-19)

**Will encourage more illegal immigration and associated costs:** Provides a healthcare entitlement for anyone who steps foot on US soil, regardless of citizenship, legality, or their contribution into the plan. (p. 50 Sec. 152), (p. 170 lines 1-3)

**Remove any choices of coverage or care:** The plan is designed to squeeze the private sector out of business and compel you to join the plan. The science of economics always indicates these kinds of arrangements result in corruption and failure to develop advancements and efficiencies.

## Loss of Freedom

---

### HR 3200 Plan Will:

**Allow complete government intrusion into all areas of your life:** This is very cleverly hidden and negates federal laws intended to PROTECT your privacy. Government will have direct access to your bank account, medical records, and any information about you that they want. (p. 59 Lines 21-24), (p. 304 Lines 17-19), (p. 503 Lines 13-19) Even allows access by "community organizations" like ACORN. (p. 476 Lines 19-20)

**Regulate and tax private insurance out of business:** Government will set all prices and standards of private insurers AND skim a fee. The government will be the referee AND the other team competing with private sector. (p. 24 Sec. 116), (p. 84 Sec.203), (p. 829 Sec. 4375)

**Allow the government to tell you if and when to have children:** Plan sends counselor to your home to micromanage procreation and rearing of children. (p. 768 Sec 1713)

**Form a government monopoly and compel you to join the plan:** If you don't have qualifying coverage, you will be taxed 2.5% of income unless you join the plan. (p. 167 Lines 18-23) Exempts government from judicial review of price fixing. (p. 121 Sec. 223), (p. 124 Lines 24-25)

**Usurp state powers:** Allows a "Commissioner" to negate State-based plans (p.111 Sec.208)

**Take action TODAY to stop this abomination and assault on your very existence. This is a battle of enormous importance!**
